This letter is written in regards to the Appeal bond filed with this Court around April 10, 2017 involving the above mentioned case. In this Appeal a plethora of evidence, documents, witness statements, facts and supporting case law was misplaced and left out of the appeal bond which should have been included to meet the exceptional circumstances to qualify for the appeal bond to be granted. I write to request that a subsequent/second appeal bond be allowed or the additional information/litigation be considered since Trey A. Williams has always asserted his innocence in this case and zero physical evidence of criminal sexual conduct was found and his entire General Sessions proceedings was a miscarriage of justice. Trey Williams also turned himself in to the police in this case seeking for justice and was living with family related to him and the victim for up to one month after the accusations were against him and known in the case which demonstrates zero threat to the victim and family. Community college instructors, community political activists, family members related to the victim, job occupational staff etc all have statements in support of Trey Williams coming home and him having a job, place to stay upon coming home. Trey Williams was also stabbed up October, 2017 several times and sent to emergency room and it is current threats on his life here.
