
Dear Ms. Kitchings:

I writing to informed S.C. Court of Appeals that Record On Appeal for Case#2016-000598 is incomplete due to newly discovered information that was suppressed because of work injury to head and memory loss. They took advantage of a disability to deceived.

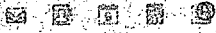

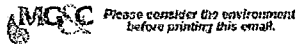
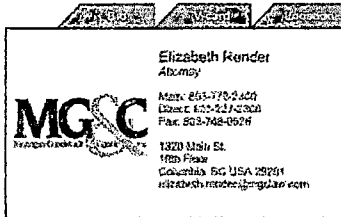
