**ORDER DENYING
DEFENDANT BOBBY J. BELLAMY'S
MOTION TO RECONSIDER, ALTER,
AMEND THE MASTER'S ORDER AND
JUDGEMENT OF FORECLOSURE
AND SALE PURSUANT TO RULES 52
AND 59(e), SCRPC**

It is therefore Ordered that the Motion to Reconsider is denied.
