Dear Ms. Kitchings:

Respondents are in receipt of Appellant's August 15, 2018 letter concerning the number of copies of the Record on Appeal he must serve and file. Pursuant to Rule 210(b), SCACR, Appellant is required to "serve a copy of the Record on Appeal on each party who has served a brief." Thus, he need only provide one copy to Respondents; however, Respondents request that he provide that copy to the undersigned.

Appellant also seeks to file fewer than the required number of copies of the Record on Appeal with this Court. However, Pursuant to Rule 210(b), "[t]he appellant *must* file with the clerk of the appellate court fifteen (15) copies of the Record on Appeal no later than the date his brief(s) are due under Rule 211." Rule 210(b), SCACR (emphasis added). While current Rule 267(f), SCACR, provides that "the number of copies required to be filed may be reduced by order of the Supreme Court," Appellant has not directed his request to the Supreme Court. Furthermore, Appellant has provided no explanation as to why he should be allowed to file fewer than the required number of copies and has not provided any evidence that he should be allowed to proceed *in forma pauperis*. As a result, Respondents request that this Court deny Appellant's request to file fewer than the required number of copies.
