
Dear Madame Clerk:



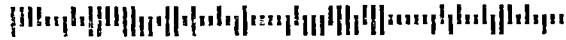
