
1. Respondent served its Initial Brief of Respondent on August 8, 2018, making Appellant's Reply Brief due on August 20, 2018.





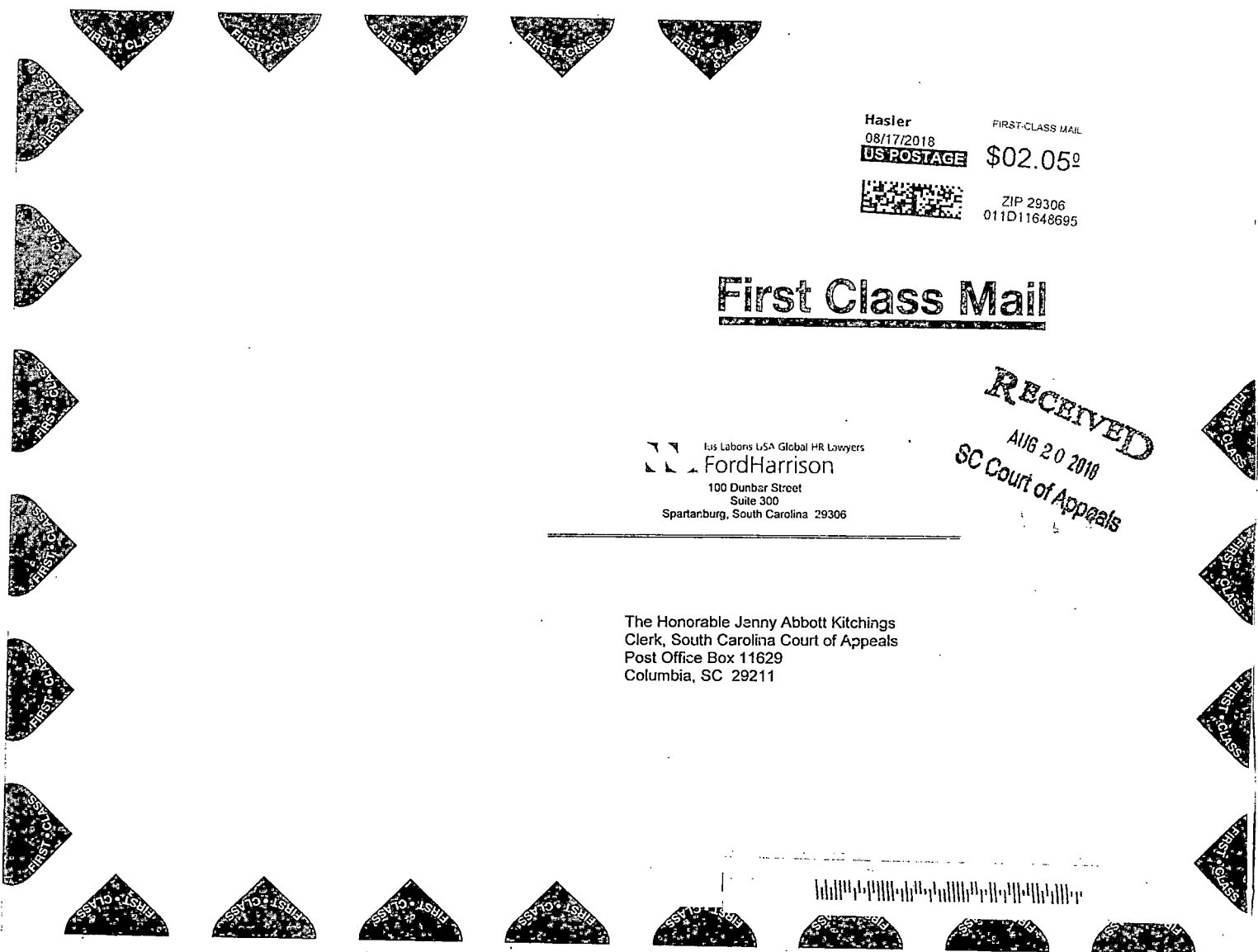
