
RESPONDENTS' MOTION FOR AN EXTENSION



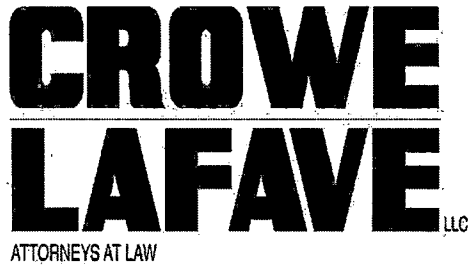
