
**MOTION FOR EXTENSION OF TIME TO FILE

Boscia, III, MD, and Upstate Lung & Critical Care Specialists, PC ("Appellants") requests an additional thirty (30) days within which to serve and file their Record on Appeal in this matter. Appellants filed their Initial Reply Brief on July 30, 2018. Upon information and belief, Appellants' Record on Appeal is currently due on Wednesday, August 29, 2018. Appellants' counsel needs additional time to collect, organize, number, copy and bind the voluminous number of documents that have been designated as matter in this appeal. Appellants therefore requests a thirty (30) day extension of time to serve and file the Record on Appeal, through and including September 28, 2018.

The page count for the Record on Appeal thus far exceeds six thousand (6,000) pages, with more to be collected and organized. The current quantity of pages collected would result in producing more than ninety thousand (90,000) printed pages or more than forty-five thousand (45,000) sheets of paper for the copies required to be filed with the Court of Appeals. Additionally, more than eighteen thousand (18,000) pages will need to be produced for the copies for all counsel involved. Appellants respectfully request that the court allow a reduction in the number of bound copies required for filing.



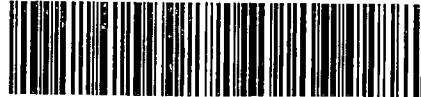
