
1. The petition for writ of certiorari and accompanying appendix in this case are due to be served and filed today.

Counsel filed the petition for writ of certiorari and appendix in the case of John Kirby v. State with this Court on July 16, 2018. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. David Vincent with the Court of Appeals on July 5, 2018. Counsel will file the initial brief of appellant and designation of matter in the case of The State v. Charles C. Brown with the Court of Appeals on July 5, 2018. Counsel filed the petition for writ of certiorari and appendix in the case of Michael Couch v. State with this Court on June 25, 2018.




