
RESPONDENT’S REPLY TO APPELLANTS’ RESPONSE TO MOTION TO DISMISS

Respondent Stephens Remodeling, LLC, submits this Reply to Appellants’ response to Respondent’s Motion to Dismiss Appeal.

Respondent moved to dismiss the appeal because Appellants failed to abide by the requirements of Rule 203(d)(1)(A) SCACR, by not timely filing a notice of appeal in the lower court. Not only does the Respondents’ Response to the motion have the wrong Appellate Case Number, but the response is almost entirely dedicated to arguing about cases other than the instant appeal.
