MOTION FOR AN EXTENSION OF TIME

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.



Counsel filed the petition for writ of certiorari with the accompanying appendix in the case of Steven Randall Cobb v. The State with this Court on July 23, 2018. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Devante Antonio Grant with the Court of Appeals on July 20, 2018. Counsel filed the petition for writ of certiorari with the accompanying appendix in the case of Antonio Romeo v. The State with this Court on July 18, 2018. Counsel filed the petition for writ of certiorari with the accompanying appendix in the case of Eric Wright v. The State with this Court on July 2, 2018. Counsel filed the petition for writ of certiorari with the accompanying appendix in the case of Chavis Aikman v. The State with this Court on June 27, 2018.


4. Counsel makes this request in good faith and not for purpose of delay.
5. Counsel for the Attorney General's office has been informed of this request.

WHEREFORE, the undersigned counsel would respectfully request a thirty day extension, in which to file the Petition for Writ of Certiorari and Appendix in this case based upon the above exigent circumstances. 


