MOTION OF APPEAL

"Sherer v. Cullen 481 F 946

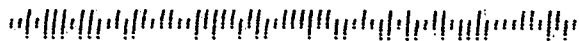
That mean that you can't dismiss my case and punish me for not performing because I am exercising my right and I am being punished by dismissing my case and not allowing me to seek damages for my injury.

I do not consent to you dismissing my case.



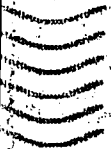
