MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE INITIAL BRIEF OF APPELLANT
AND DESIGNATION OF MATTER

Counsel for Antonio L. Dodd respectfully requests an extension of thirty (30) days in which to file the initial brief of appellant and designation of matter in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The initial brief of appellant and designation of matter is due to be served and filed with the Court today, January 14, 2013.
2. Counsel for Mr. Dodd respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the number of extensions previously granted and the order in which counsel attempts to manage his caseload, counsel hopes that no further extension requests will be required.

On October 5, 2012, counsel filed the brief of appellant and designation of matter and record on appeal in State v. Chanton Edjuan Smith with this Court. On October 4, 2012, counsel had an oral argument in State v. Rushan Counts with this Court. On October 1, 2012, counsel filed the petition for writ of certiorari and appendix in James Russell v. State in the Supreme Court.


4. Counsel makes this request in good faith and not for purpose of delay.


