- (1) You may not include exhibits to the petition for a writ of certiorari. *See* Rule 242(d), SCACR (listing what may be included in the petition). Instead, all of the material specified in Rule 242(e)(2)-(4) will need to be included in the appendix.
- (2) Since you provided only unbound copies of the appendix, you will need to provide a bound copy of the appendix. Rule 242(e), SCACR ("the petitioner shall also file two (2) copies of the Appendix with the Clerk of the Supreme Court. As provided by Rule 267(d), one copy filed with the Supreme Court shall be filed unbound.").<sup>1</sup>
