
At a Court of General Sessions, convened on March 23, 2017, the Grand Jurors of Horry County present upon their oath:

Personally appeared before me the affiant A Amick who being duly sworn deposes and says that defendant Lonzie Carl Johnson did within this county and state on or about 10/5/2016 violate the criminal laws of the State of South Carolina (or ordinance of County/ Municipality of Myrtle Beach) in the following particulars:

DESCRIPTION OF OFFENSE: Murder / Murder

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On October 5th, 2016 Officers with the MBPD responded to [redacted], which is located within the City of MB, for a reported assault. The investigation revealed that the victim and defendant exchanged words. During the verbal dispute the defendant pulled out a knife and stabbed the victim. In that the defendant inflicted injury on the victim and the injury contributed mediately to the victim's death on October 9th, 2016, there is probable cause to believe the defendant did commit the offense of Murder 16-03-0010.
