I represent the Petitioner in the above-captioned matter. I am in receipt of this Court's Order, dated June 28, 2017, granting Respondents an extension in which to file their Brief, until July 24, 2017. If Respondents file their Brief on that date, then Petitioner's Reply Brief must be served and filed 10 days later, on August 3, 2017.

I am mindful of the Court's Order, dated July 16, 2014, which limits extensions totaling more than 20 days to extraordinary circumstances. I was previously granted a 10 day extension in which to serve and file Petitioner's Brief and the additional copies of the Appendix.
