

At a Court of General Sessions, convened on January 12, 2015 the Grand Jurors of Edgefield County present upon their oath:



I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

In that between 10/09/2014 at 2230 hours and 10/11/2014 at 1110 hours, the defendant along with another did knowingly, willingly and unlawfully and with malice aforethought enter the victim (Johnny Hydrick's) residence without his consent or permission with the intent to commit a crime therein. Once inside the defendant did beat the subject to death and then did take, steal and carry away pills, money and rifles. By taking these rifles, the subject became armed. This occurred at 103 Windy Ridge Road, Trenton, S.C. 29847. Same being in Edgefield County.
