This follows my telephone conference of this morning with the Court and will confirm that our offices and staff are located in an area that will be under mandatory evacuation beginning at noon tomorrow, 9.11.18. Our Reply Brief would be due on Friday, 9.14.18. Because of staff safety and weather impact, we may need a bit of additional time to file and serve. Frankly, given the uncertainty of power outages and the ability to return to the area, we are not certain of how much additional time to request at this point, but it could be between 10-14 days - again, depending on impact.

We will do whatever we can to try to get the brief to the Court timely, but do not know if that will be possible. Therefore, we would appreciate the Court's consideration and hope that perhaps the Court will be issuing an Order dealing with deadlines impacted by the hurricane and mandatory evacuation.
