As a result of said Appellant counsel's work schedule, Appellant respectfully contends that good cause exists for an extension of time to file its Initial Brief and Designation of Matter.



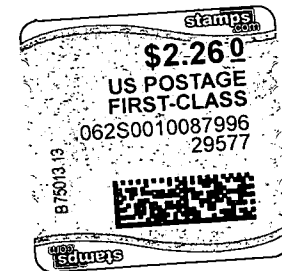
