
**Notice of Appeal**

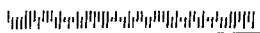
