my name is Robert Wilson woods I am
~~currently incarcerated~~ ^{incarcerated} in the South Carolina
Department of corrections at Broad River
corrections, I am asking and requesting that
your court review my case and transcript
on these conditions. I was charged with
criminal sexual conduct with a minor first
degree Indictment number 2012-GS-23-2853
and a separate count of lewd act upon a child
2012-GS-23-2852. I ~~went~~ ^{went} to trial on both
charges, my county police Department receives
my warrants on november 15, 2011 and The
clerk of court of Greenville county Received
Them on november 18, 2011. I was indicted
on March 19, 2013 which is over the 90 day
Process Rule 3 SC crimp. I was found Guilty
on Both ~~charges~~ ^{charges} the Judge Robert E. Hood
sentenced me to 25 years on Criminal sexual conduct
first degree and a consecutive sentence on
lewd act which was 10 years suspended to 5 years
of probation. The reason that I am writing you
is because I am being held fastly and was wrongly
accused of a crime that never happened or took place

The victim in my case has a prior Allegation
Back in 2009. ~~The allegation~~ ^{The allegation} that was made was
false. The victim accused a man & kidnapping
her and Raping her. if you review my transcribe
look at page 16-27, she the victim did not make
the allegation But she gave an statement
to the Investigator Cheryl Cromer f.c which
was on December 1, 2009 and she was 7 years old
at that time. during the investigation the
potential perpetrator which she named was
Kevin was never questioned or any arrest was
made. now if you would need that allegation
that was false cause at one point she did not
know who the perpetrator was until ask at
her medical exam and her forensic exam, her
medical exam come back normal. now in my
case, she stated that I analy penetrated her
transcript page 130-144. in my case she the victim
stated that I told her to come in her mom's room
and take her clothes off and that this will help
you to stop scratching. During this she said that
I had all my clothes on from head to toe, she
said that my hands never touched her that they
was on the Bed the whole time. ~~and~~ she also stated
that I did this to her mom put my priv. etc

in ^{her} Brett, she stated she never saw this she just heard it, she stated she heard her mom scream now my question is if my hands was on the bed and they was not touching her or holding her how can I take my private out and put it in her buttocks and if I did the same to her mother and her mother screamed from it why she didn't scream she stated it was uncomfortable, my trial counsel asked her if she the victim made any noise or hollered or any thing she said no. pgs 138 line 9-11 she was questioned about Lisa being in the house and her brother, she stated she never saw my private, never saw me put any thing on it or put it up, so again if my hands are on the bed how can I take my private out of my clothes with out using my hands, this child is eight years old at this time, I know if a grown woman screams at something like that, what will an eight year old will do, she never went to the hospital to be checked or any thing, until January 12 2012, from the day of the allegation which was September 29, 2011 to January 12, 2012, I'm in my appeal for mental health I already know they oint gonna give me any ~~more~~ ^{relief} so I'm gonna do a nother PCR to have all my issues

ruled on. I was falsely accused of this
crime and I need all the assistance that
I can get. My 6th amendment was violated
because the judge denied me the right to
confront my accuser about the 2009 case
and statement she made to the investigator
Cheryl Cormatic

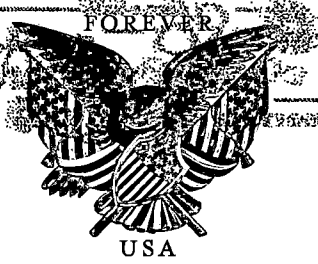
