**MOTION TO AMEND
RESPONDENT'S BRIEF ON THE MERITS**

Respondent respectfully moves this Court for leave to amend her Brief on the Merits.

Respondent's motion is based on the following grounds:

1. By Order dated August 2, 2018, this Court set an expedited identical briefing schedule in the following cases:

- a. Appellate Case No. 2018-000662
- b. Appellate Case No. 2018-000566
- c. Appellate Case No. 2017-000743

2. The Court's Order further specifies that no extensions will be granted absent a showing of extraordinary circumstances.

3. Respondent's Brief on the Merits, Appellate Case No. 2017-000743 was due to be filed and served on September 11, 2018.

4. At or around 1:00 p.m. on Monday, September 10, 2018, Governor Henry McMaster declared a state of emergency and ordered a mandatory evacuation of coastal cities in South Carolina due to dangerous weather conditions related to hurricane Florence.

5. Attorney for the Respondent resides in Charleston, South Carolina, and was subject to the mandatory evacuation.

6. On the day before the due date for Respondent's Final Brief on the Merits, counsel for Respondent was interrupted in her drafting by the necessity to make preparations for the hurricane and evacuation.

7. Further, local post offices and government buildings in the Charleston area were to close on September 11th due to the hurricane and evacuation.

8. To ensure her brief was placed in the mail by the due date, counsel for Respondent was required to hastily mail the brief in an un-edited, un-finalized state.




