
Appellant hereby moves pursuant to Rule 263(b), SCACR, for an extension of the time in which to serve and file the Appellant's initial brief and designation of matter to be included in the record on appeal. Specifically, Appellant seeks an extension of that time to 30 days from the date that Respondent's brief was due of August 30, 2018. If the request is granted, Appellant's initial brief and designation of matter to be included in the record on appeal will be due on October 8, 2018 (when considered alongside recent Supreme Court Order 2018-09-17-01 ("Re: Hurricane Florence")). The grounds for this motion are that there is good cause to grant the requested extension, as the following shows:

1. Counsel today became aware that his office received the transcript of the below proceeding on July 31, 2018.
2. It is not possible for Appellant to comply with the original deadline (August 30, 2018), as computed by Rule 263, SCACR, to supply an initial brief and designation of matter to be included in the record on appeal.
3. The Respondent consents to the requested extension.
4. Appellant has not sought a previous extension in this appeal.
5. There is good cause to grant the requested extension.

WHEREFORE Appellant prays for an order extending the time in which to serve and file the Appellant's initial brief and designation of matter to be included in the record on appeal by 30 days, to October 8, 2018.


