**MEMORANDUM IN SUPPORT OF
PETITION FOR WRIT OF CERTIORARI**

The Appellant respectfully requests that the Honorable Supreme Court of South Carolina grant certiorari to consider the decision of the South Carolina Court of Appeals of June 27, 2018, affirming the trial court. Appellant avers that the Petition for Rehearing was made and finally ruled on by the Court of Appeals on August 16, 2018.

QUESTIONS PRESENTED

Appellant avers that the Honorable Court of Appeals did not adequately consider the following issues.

1. In the summer Of 2011, Mr. Cantrell was told by the Department OF Health and Human Resources, from Aiken County that Rabies vaccinations were only required, if a certain dog bit someone,

2. In the Spring of 2015, Officer Ron Cooper stopped at Mr. Cantrell's house and enquired, about dogs in the road, Mr. Cantrell the petitioner told Officer Cooper that they were strays, and his dogs stayed inside the fenced in area. The stray dogs disappeared within several days.
3. Approximately three weeks later the stray dogs show up in my neighbour's yard Marie Fox, there were about 15 dogs, and she feed them and they stayed in her yard.
4. After several months my neighbour Marie Fox stopped feeding the dogs and ran them off with a fire arm.
5. Several people were throwing food in the road in front of my house from their vehicles to keep the dogs in the road.
6. On July 2, 2016, Officers Ron Cooper, Ashe and another Officer stopped in front of my house while I am gone to town shopping, and blocked my driveway and waits for me to return, a Ryan Gunter was watching them from my house and called me on my cell phone.
7. When I arrived Officer Cooper said they had a complaint about dogs in the road from my neighbour and he pointed towards her house Marie Fox.
8. The stray dogs ran into the road where we were and officer Cooper started writing citations for dogs in the road and failure to vaccinate, and I told him that these were stray dogs that my neighbour Marie Fox had been feeding, and that my dogs stay inside the fenced in area.
9. I told Officer Cooper that my veterinarian Lisa Handy said that you must always issue a warning first, and give time to correct any problems before you can issue a citation, and the third Officer I didn't get his name said in your case we don't half to.

STATEMENT OF THE CASE

IT appears that in 2011, when the Department of Health and Human Resources told me that rabies shots wernt required this was an attempt to set me in another of Aiken Countys traps, for future purposes.

In 2015 Aiken Animal Control changed their name Code Enforcement, There were a lot of stray dogs around the area, so Officer Cooper came and got them, they did this so they could try and get one of my dogs that were inside the fenced area into the road, by throwing food into the road, several people were involved, mainley Nick Cribb, and David Christmas.

They tried for at least three weeks, and failed, so they dumped the same dogs that they had got three weeks earlier, into Marie Fox's yard and had her feed them for at least two monthes, I guess they were using the stray dogs to try and get my dogs into her yard where they could write me a citation for dogs at large and failure to vaccinate, but my neighbour got tired of it and said that they were digging and destroying her yard.

My neighbour Marie Fox ran them out of the yard with her pistol. and Nick Cribb and David Christmas were throwing food from their vehicles in front of my house to keep the stray dogs into the road.

Then on July 2, 2015 Officer Ron Cooper, Officer Ashe and anot er Officer, blocked my driveway while I was gone to town to make me park in the road, to try and get dogs into the road, Ryan Gunter was watching them and said that not a single dog went into the road the whole time they were wating.

After I arrived back home I had to park on the other side of the road and get oust, and I asked what was going on, and officer Cooper

said that your neighbour called in a complaint about dogs in the road and pointed to Marie Fox's house. Then the strays ran into the where we were, and Officer Cooper Started writing Citations for dogs at large and failure to vaccinate.

I told Officer Cooper that these are the dogs that were staying in my neighbours yard, and that you half to write a warning before you can a citation and the third officer said that were under a new umbrella now, and in your case we don't half to.

Officer Cooper said you better not showup at the hearing without these rabie shots.

After they left I called my friend Jean Bird Smith and told her what had happened, and she said she would document it, she has been helping me with my legal paper work since 2011.

On July 13, 2015, I got a call from my cousin Roy Stewart who said that Jean B. Smith had been reported missing, I knew that Aiken County probably had done something with Jean, so I turned in a report to the FBI Office in Columbia S.C. Just before the hearing date, on July 23, 2015, in Monneta S.C. which they had planed on locking up Mr. Cantrell but the whole mood had changed so I requested a Jury trial and we picked jurors, for the trial date of August 26, 2015.

On the date of the trial Judge Willamson, had another trial, within an hour of Mr. Cantrell's, Willamson said we should be able to do this howl trial from start to finish within 35 min.

Judge had already dismissed 5 of the primary jurors that Mr. Cantrell had picked and replaced them with Officer Coopers pick.

Mr. Cantrells witness his neighbour Marie Fox that he had subpona for the trial never was contacted by the court, so he complained that the trial should be rescheduled, and Willamson went and called Marie

Fox , and said that she would be thair in about 35min.

They had no intentions of bringing in Marie Fox because she will tell the truth but she wont tell the whole truth.

When Marie Fox was on the stand she said that she had been feading 10-15 dogs and that they were staying in her yard and that they were destroying her yard. and Judge Willamson said that this has nothing to do with this trial. (on October 30, 2017, Mr. Cantrell was talking with his neighbour Marie Fox at her Mail Box about the stray dogs and she told him that Animal Control was the ones dumping out the stray dogs and it was for corrupt reasons).

Officer Cooper had chainged his story to we just happend to be going down MuddyBranch Road and seen dogs in the road and stoppéd (On the day they wrote Mr. Cantrell the citations Mr. Cooper said that your neighbour complained about dogs in the road) I asked Marie Fox about this in the court room and she said her son inlaw Donnie Boatwrite filled the complaint.

Ryan Gunter was a witness that seen the whole thing and said that there never were any dogs in the road the whole time that Mr Cantrell was gone until after he got out of his vehicle.

This was a rigged Trial with a rigged jury and Judge Willamson said that you better pay this fine today or your going to spend 30 days in jail.

This whole attack was to keep from giving Mr. Cantrell time by issuing a warning like Lisa Handy Mr. Cantrell's veternaire said they must always issue a warning first and give you time to correct any problems, in order to lock Mr. Cantrell up and has Junior Enlow stated to get rid of you and take everything away from you.

ARGUMENTS

The main reason for these attacks on Mr. Cantrell by Aiken County, is because the area that he lives in is being used has a means for bringing in Millions of dollars in Cocaine and possibly in the Billions dependion on the amount of air traffick by Military Aircraft, and comercial and small airplanes being landed in the fields around Mr. Cantrells Dwelling place mostely at the river where the power lines cross the river.

The Aiken Airport is being used for a front, the old radar system was removed in the mid. 90's, and was replaced by a beacon detector, this allows the drug traffic to fly directly over the airport without anything showing up on the radar, and since the air traffick is flying below 500ft. it doesnt show up on the larger radars at the Augusta and Columbia Airport.

Aiken County uses the corrupt law enforcement and several Judges to prosecute the innocent that refuse to go along with their corrupt system and also those that are involved in the drug Trafficking can get away with murder without being prosecuted by this same corrupt system.

The County of Aiken is involved in Drug Trafficking, Money laundering, Human Trafficking, kidnapping, using the Military and their equiptoment for drug trafficking purposes. these are Federal Crimes and should be taken to the Federal Court System, because the State Court System will always protect the states interest no matter what.

I had put in the Final Brief in the Appeas Court about the drug trafficking is the reason for this attack in the Conclusion but when i got my briefs back from the Court of Appeals it appears

that this had been removed, and back in February of 2018 all my records and everything including my computer had been destroyed in a fire, which I know was intentionally set for that reason to destroy my paperwork and records. But I did put a line regarding the Drug trafficking in the Summons and Complaint in The Record on Appeal.
