
APPELLANT'S MOTION FOR EXTENSION TO FILE PETITION FOR REHEARING



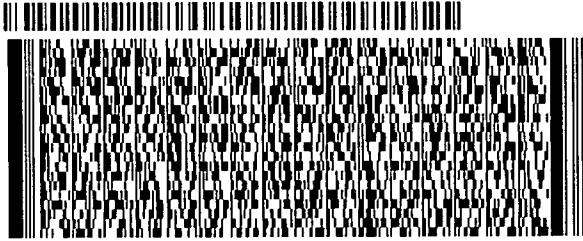
