My name is Julie Lynn Gookins and I am presently incarcerated in SCDC at Camille Graham Griffin Correctional Inst. I am in the process of appealing my p.c.R. that was rejected and have been actively working on my appeal. While I didn't have an attorney I wrote to Solicitor Anne Williams, Solicitor Scarlett Wilson, whom I understand is her boss, the clerk of court for Berkeley County Mary P. Brawn, Moncks Corner Municiple Court who I was referred to by the Berkeley Co. Clerk of Court and to my ex public defender David P. 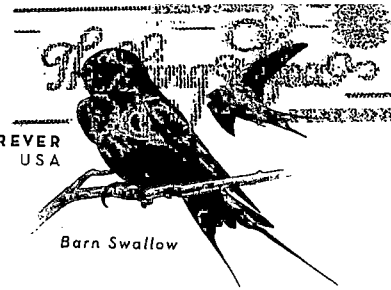
