This letter is to request a thirty-day extension of time in which to file the Initial Brief of Respondent and his Designation of Matter to be Included in the Record on Appeal with regard to the above referenced appeal.

I currently have other obligations and deadlines that will prevent me from completing the initial brief by the current deadline. Specifically, I was at the Fourth Circuit for an oral argument that took me out of the office on September 24 and 25.
