I received your letter yesterday, ~~24~~ September 2018, advising me that I must submit a \$25 filing fee for my motion to allow late filing. The copy of the SCACR that Lee Correctional Library has, titled Annotated Court Rules, does not include a fee-schedule for filing motions. I apologize, because I simply did not know that a fee was required.

From what I currently understand, SCDC will send the check back to Lee prison and then I will re-mail it to the court. I think.

In any event, I will begin this process and send the \$25 fee as soon as possible. I hope that this will enable me to file the motion to allow late filing, and I apologize for not knowing the rule. The Library officer here at Lee prison consulted the electronic rules for confirmation.

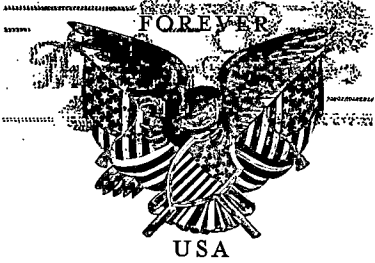
