I motion to Relieve Counsel of Record and so prose prejudice
Because counsel is ineffective and was hired to be my full counsel
on a plethora of diverse cases involving Appeal bond, me being injured
and this Appeal. Counsel then after being paid told me that he is
only focusing on my Appeal bond and he neglected to handle that
according to LAW and our Agreement. Being that I filed my Return
in this case on Appeal prose because of continuous ineffective
assistance of counsel from General Sessions in 2009 - Collateral
Appeals up until the above date I have had admissions, lack
of Evidence to Resolve future disputes be left off the Record,
unfair Bite At the Apple not having an Adequate PCR
Hearing and missing documents off the Record, INVALID transcripts
with complete issues being left off the Record as well as my
SQ AORE motion being neglected by counsels of Record. MR. BAILEY
has Refused to fix or do Any thing to Resolve these matters but he
motioned to the court two diverse events stating he IS counsel of

Record in this case as well as stating to the court on another time that he is only here to do the Appeal Bond. He informed me as my counsel that he would represent me and fix everything involving my case when I was going to remove him once, under his advice and since he said to the court I kept him as my attorney but he then tells me he is not going to do anything on my case. This prejudiced my entire appeal process, presenting me to fix the record on appeal for federal review and my appeal bond. My post conviction relief hearing transcript has missing issues in it and testimony and the PCR hearing was not adequate having expert witnesses, witnesses, records, evidence and documents supporting actual innocence, abuse of discretion, prosecutorial misconduct, cumulative error, ineffective assistance of PCR counsel, ineffective assistance of trial counsel/stand by counsel, invalid waiver/relief of counsel and jury trial as well as my mental health records, invalid indictments, double jeopardy and grand jury issues and violation of protected right 1. speech, and press from trial etc that most was mentioned in my amended PCR application that was heard before the PCR judge but is not in the appendix. Also a false imprisonment claim, many documents have been kept off the record and or edited in a manner to deprive me of fair procedures but I have incontrovertible evidence and due diligence of me striving to preserve and safeguard my rights, issues etc on a official court record such as S.C. Supreme court and York County clerk of court general sessions and PCR files. I intend to file an "extraordinary writ" to be heard and to go transfer to the federal courts to be heard in this case

Before it is ruled on by way of showing substantial evidence supporting the violations and errors mentioned in this motion and more in the interest of justice of one who is falsely imprisoned, actual innocent but being held in prison by way of fraud from prosecutor of General Sessions/Trial Judge and all attorneys of record in the totality of this case. With this attorney off this case I will then be able to file all the necessary motions, documents and evidence to show all evidence, supporting facts and due diligence to safe guard for federal review and get a full and fair evidentiary hearing years to come. I would also like to ask this court or any federal courts for an appeal bond and if the time serve plea that I was offered in 2009 is still available as I was told it was not long ago I want to take a time serve plea to end this entire case matter but I will not be procedurally barred from any issue of federal review. After my PCR hearing was over the attorney general of PCR record left the case, at PCR hearing he testified that my waiver of counsel was not in compliance with Faretta, and stand by counsel testified the same thing as trial transcripts indicate. In my PCR Amended Application I requested through PCR counsel of record to have expert witnesses, witnesses, mental health records and other exhibits at the PCR hearing and I have documents filed by PCR counsel to my mental health facilities since I was 8 and 19 years old, IDSS etc requesting for my records shortly before PCR hearing took place and counsel failed to mention it to PCR judge and I was prevented at the start of PCR hearing from speaking on it. Expert witness evidence is expert witnesses / doctors even from
TRIAL testifying to ACTUAL INNOCENCE AND PROSECUTORIAL MISCONDUCT
and how RAPE IS NOT ADEQUATE AND THE MEDICAL EXAMS AND
PROCEEDURES WAS DONE WRONG AND IT PREJUDICE ME IN FAVOR OF
THE PROSECUTION TO RENDER AND SUBMIT MISLEADING FAULSE EVIDENCE.
IN THE REAL PCR APPLICATION AMENDED IT STATES EVERYTHING THAT
SHOULD HAVE BEEN DONE AT PCR HEARING AND PCR COUNSEL TOOK ALL
OF IT OUT AND FILED THE EDIT VERSION WHICH IS ON PCR RECORD
BUT COUNSEL DID NOT FILE ANYTHING OF HIS OWN WORK. S.C. SUPREME
COURT AND YORK COUNTY CLERK OF COURT HAS AND HAS MY DOCUMENTS,
ISSUES, CONCERNS FILED ON RECORD WELL BEFORE MY PCR HEARING.
I ALSO TESTIFIED HOW PCR COUNSEL WAS INEFFECTIVE AT PCR HEARING
WHICH IS RAISED IN AMENDED PCR APPLICATIONS, I HAVE LETTERS
FROM HIS VERY OFFICE OF HIM TELLING ME I HAVE ZERO ISSUES
THAT I CAN EVEN RAISE FOR A PCR HEARING ETC. I ENDED UP
HAVING HIM RELIEVED AFTER PCR AND ANOTHER ATTORNEY GETS ON CASE
AND SAYS HE IS NOT FIXING ANYTHING, FILING ANYTHING ON MY CASE

of Courts for other Records showing my evidence and due
diligence. York County Clerk of Court General Sessions Records I
have will show that stand by counsel was ineffective to me and
that I listed many concerns prior to relieving him. York
County Clerk of Court PCR Records will show my due diligence
on getting effective assistance of PCR counsel and a full
fair bite at the apple. S.C. Supreme Court Records will
show my due diligence in safe guarding issues for
Federal Review. How the totality of this motion to relieve
counsel document is relevant to being heard as merits to
relieve counsel is meritorious because it is clear and factual
that counsel of record is not and has not represented me in
this appeal case so that is "actual prejudice"; also it prevents
me from any filings to correct error and it is a broad discretion
from this court to review the content in this motion and send
case to proper stages to correct error if extraordinary
circumstances reflect the merits and in this case it
does so I would like a full fair and complete opportunity
