

Counsel filed the initial brief of appellant and designation of matter in the case of In the Matter of the Care and Treatment of Robbie Collins with this Court on August 22, 2018. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Courtney Price with this Court on August 2, 2018. Counsel filed the brief of petitioner in the case of Isaac Starke v. The State with the Supreme Court on August 1, 2018.




