There are many documents that Appellant needed Pro Se, to prepare and complete the record on appeal and proof of service in a timely manner. 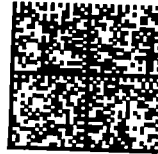

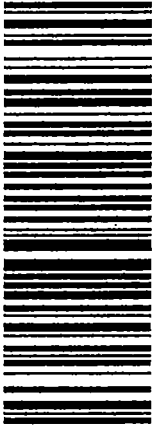
