MOTION FOR AN EXTENSION OF TIME

Counsel filed the petition for writ of certiorari with the accompanying appendix in the case of Marty Baggett v. The State with this Court on August 6, 2018. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Jeffrey Michaelson v. The State with this Court on July 30, 2018.

5. Counsel for the Attorney General's office has been informed of this request as shown by signature below.


