Dear Madam Clerk:

We initially filed two separate appeals, appealing a Receiver Order entered July 23, 2018 and a Final Judgment and Order related to a week-long trial entered April 2, 2018. By letter dated August 7, 2018 from the South Carolina Court of Appeals, the two appeals were consolidated.

While we have received the transcript from the hearing resulting in issuance of the Receiver Order, the Court Reporter compiling the transcript from the trial has requested and was granted an extension through November 1, 2018. Pursuant to Appellate Rules, our receipt of the hearing transcript triggers initial brief filing deadlines related to the Receiver Order however because the Court consolidated the two appeals, we are unsure how to proceed since we are still awaiting receipt of the trial transcript.

We respectfully propose that filing deadlines be triggered upon our receipt of the trial transcript. Please let us know how the Court would like us to proceed and if any formal filings to address this issue are necessary.


