Dear Mr. Shearouse:

I am writing concerning the oral argument for the referenced Appellate Case that is scheduled for 10:30 a.m. on Thursday, October 18, 2018.

The remaining Appellants, following the stipulation of partial dismissal filed on September 27, 2018, are National Fire & Marine Ins. Co. ("National Fire") and Hartford Fire Insurance Company and Hartford Casualty Insurance Company ("Hartford"). The Appellants are allotted an initial fifteen (15) minutes to argue and five (5) minutes for a reply. I will argue on behalf of National Fire, and Steven M. Klepper, Esq. will argue on behalf of Hartford.


I am writing to advise the Court that, if satisfactory to the Court, Mr. Klepper and I will both argue and will split the initial fifteen (15) minute allocation equally. I will begin and argue for seven and one-half (7.5) minutes, and Mr. Klepper will argue for the remaining seven and one-half (7.5) minutes. We both understand that questions from the Court may alter these time frames and will be ready to adjust accordingly.

Appellants recognize that it would likely be impractical to divide the five (5) minute allocation for the reply. For that reason, the Appellants have agreed that I will argue on behalf of National Fire for that five-minute allocation. Mr. Klepper will, however, be ready if the Court has any questions it wishes for Hartford to address in reply.

Should this division of time be unsatisfactory in any way, please do not hesitate to contact counsel and advise us.
