


Dear Ms. Kitchings:


Dear Elizabeth

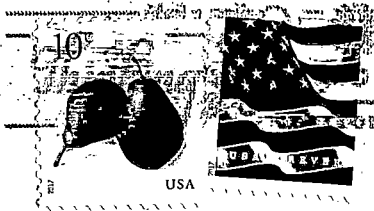
