MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION FOR WRIT OF
CERTIORARI AND APPENDIX

Counsel respectfully requests a **final extension of thirty (30) days until November 14, 2018**, in which to file the petition for writ of certiorari and appendix in this case. 
petition for rehearing in the case of State v. Samuel Edward Alexander, Jr. in the Court of Appeals on August 9, 2018.

5. Counsel for the Attorney General's office consents to this request as shown by signature below.




