

NOTICE OF APPEAL

Appellants DataQuick Lending Solutions, LLC formerly known as DataQuick Lending Solutions, Inc. (collectively "DataQuick") hereby appeal from (1) the Order of Judge L. Casey Manning entered September 19, 2017, granting Respondent's Motion for Default Judgment with Attorney's Fees and (2) the Order of Judge L. Casey Manning entered September 19, 2018, denying DataQuick's Motion for New Trial, to Alter or Amend Judgment, and for Relief from Judgment. 
