I am writing on behalf of Appellant National Fire & Marine Insurance Company (“National Fire”), regarding the referenced Appellate Case and, in particular, the oral argument scheduled for 10:30 a.m. on October 18, 2018.

As the Court is aware, most of these consolidated appeals were previously dismissed pursuant to settlements of the underlying claims. The only remaining Appellants are National Fire and Appellant Hartford Fire Insurance Company and Hartford Casualty Insurance Company (collectively “Hartford”), who both insured Coastal Plaster Systems, Inc.


National Fire, Hartford and Respondent have reached a settlement in principle with respect to all the Respondent’s claims against Coastal Plaster (and National Fire) and the appeal. A condition of the settlement is that National Fire join in a motion with Hartford and Respondent to dismiss the appeal. National Fire has agreed to do so. The parties will be separately filing the motion to dismiss.
