
MOTION TO FILE OUTSIDE OF TIME AND MOTION FOR EXTENSION



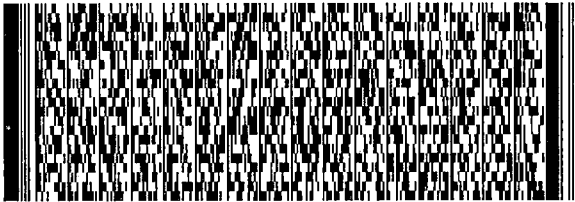

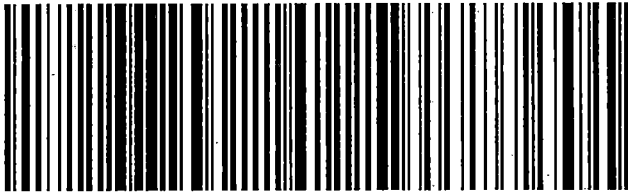
