WHEREFORE, if the Appellant Motion to Relieve Wanda H. Carter is granted, Will this Honorable Court Please Consider this Matter. ....

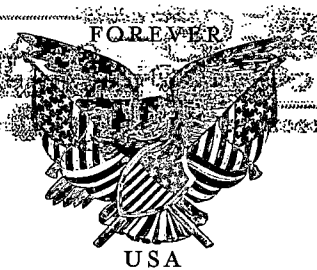
