
MOTION FOR COSTS



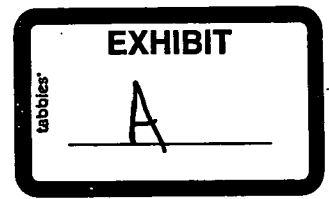


