Dear Court of Appeals

The arresting officer on my case can't be trusted. He's had it out for me the longest from past flaws I've had getting in trouble and he always told me he would put me away for ever and getting sentenced 30 years in prison is pretty much for ever. From my understanding my plea offer was only to be from 0-15. But my attorney said with the armed robbery I couldn't have gotten no less than 10 years. So my lawyer told me the plea would be from 10-15. But once I signed the paper the solicitor said you agreed to the 0-30 plea. I asked him why would I do that if I agreed to the 10-15. He said "well This is the only offer for you if not its trial. And told me I would get 60 years. But I told him an open plea ~~from~~ from 0-30

was outrageous because I could get the whole 30 years. All he said was Beats life in prison. 30 years is life in prison. is what I said. I was young and didnt understand most of it. But agreed out of the trust I had in my lawyer. The solicitor told me dont worry the judge is a forgiving person he wont give you the whole 30 years ~~can~~ can promise you that. There were just so many flaws But I didnt know at the time. But now I do and want you guys to review all mistakes made.

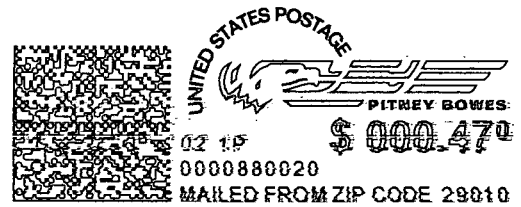
