To be succinct and to the point..... The South Carolina Department of Corrections and some of the Defendants "You All" represent in the above referenced cases ARE ILLEGALLY WITHHOLDING ALL OF MY LEGAL FILES/PAPERWORK/ETC. from me.

This includes All of my legal files for the one (1) Criminal Case that I am unlawfully in prison for, All of the legal files for the other FIVE (5) Criminal Cases (Almost forty charges after Indictments were handed down) that me and my Trial Counsel (I.S. Leavy Johnson) FORCED the Sumter County Solicitor's Office to dismiss, All of my legal files for the Civil Action that I filed against Simon Major Jr. (Former Director of Sumter/Lee Regional Detention Center) that was settled "Out Of Court" in August 2003, All of my legal files for the above referenced Civil Actions that I had accumulated between 7 May 2018 to 22 August 2018, All of my legal files for CIA No. 0:18-1309-CMC-PJG, All of my Journals and Log Books, All of my case laws, All of my Federal Rules Of Court, All of my South Carolina Rules Of Court, All of my legal notes/roughdrafts/Table of Contents for All of the above referenced files/cases, and basically ..... All of the legal files/paperwork/books/log books/etc. that I have been using to REPRESENT MYSELF in the herein referenced Civil Actions that you All are the Counsels Of Record for.

TAKING and REFUSING TO RETURN my herein referenced "Legal Files, Etc." is a DESPERATE "Retaliation Tactic" being used against me for filing a very LARGE quantity of SCDC 10-5 FORMS and SCDC 19-11 FORMS that put forth conclusive/matterial facts that proved that the South Carolina Department of Corrections' Mental Health Program is STILL CAVALIARLY subjecting its Mental Health and ADA Residents to "substantial" risk of "Serious And Irreparable Physical/Psychological Harm"..... And the said "Retaliation Tactic" is likewise being carried out in response to the FOUR (4) herein referenced Civil Actions that are currently pending before the Honorable United States Magistrate Judge Paige J. Gossett (Cases that will CONCLU-

-SIVELY show after Discovery is complete and at trial that I have been the victim of the sadistic/malicious OFFICIAL MISCONDUCT that Judge Michael Baxley expounded on in his 8 January 2014 forty-five (45) page Order).

As You All are aware ..... A "Retaliation Tactic" such as this is a DIRECT violation of my United States Constitutional Rights (To be free from ALL forms of such RETALIATION), so I hereby ask that You adhere to the "Oath" You took and the Rules Of Professional Conduct that You live by and advise "Your Client" (The South Carolina Department Of Corrections) To IMMEDIATELY RETURN my herein referenced "Legal Files, Etc.", upon Your receipt of this letter.

PLEASE NOTE ..... This "Retaliation Tactic" is now affecting the case that I have pending in the South Carolina Court Of Appeals (Appellate Case No. 2018-000552). I received a letter from Deputy Clerk V. Claire Allen advising me that I am UNDER A COURT DEADLINE to secure a transcript "Connected To CA No. 0:18-1417-CMC-PJG" ..... And because Your Client is STILL ILLEGALLY withholding ALL of my herein referenced "Legal Files, Etc.", I AM NOT at liberty to construct and file a "detailed" Motion For Appointment Of Outside Counsel in response to the said "deadline".
