

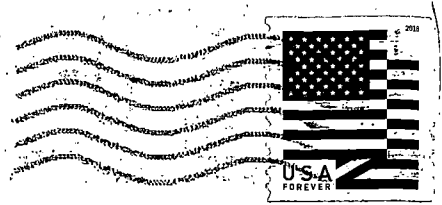
STATEMENTS OF THE CASE
