
**RESPONDENTS' JOINT RETURN IN OPPOSITION TO APPELLANT'S
MOTION TO SUPPLEMENT THE RECORD ON APPEAL**

Pursuant to Rule 240(e), SCACR, Respondents South Carolina High School League and E.A. "Rico" Williams submit this joint return in opposition to Appellant Aminah A. Richburg's October 29, 2018 motion to supplement the record on appeal. The Court already granted Respondents' motion to strike the proposed documents from the record on appeal in a prior order because they were never presented to the circuit court. In fact, all of the proposed documents are dated after the circuit court entered the order from which Appellant has taken an appeal. Therefore, Appellant's second attempt to include these documents in the record on appeal is unavailing. As to her request that any documents be "relevant and original," the Court already found Respondents' proposed matter was relevant and nothing in the South Carolina Appellate Court Rules requires that original copies of documents be included in the record on appeal.

Accordingly, for the reasons set forth above, the Court should deny Appellant's motion to supplement the record on appeal because it is manifestly without merit.




