
Counsel respectfully submits that an extension would serve the ends of justice and provide Counsel adequate time to prepare the petition and appendix.



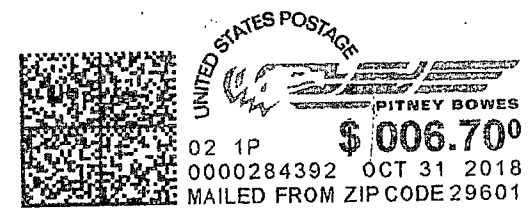
