GENERAL POWER OF ATTORNEY

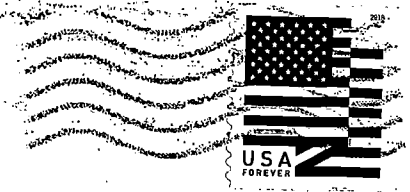
