
number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Forrest Nelson, Jr. v. The State with the Supreme Court on September 28, 2018. Counsel filed the Anders brief of appellant pursuant to White v. State in the case of Cary Glenn Ryals v. State with the Supreme Court on September 24, 2018. Counsel filed the petition for writ of certiorari and accompanying appendix and supplemental appendix in the case of Cary Glenn Ryals v. State with the Supreme Court on September 24, 2018. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Ronald Edward Gooden v. The State with the Supreme Court on September 17, 2018.

4. Counsel makes this request in good faith and not for purpose of delay.


