
Dear Mrs. Richardson,

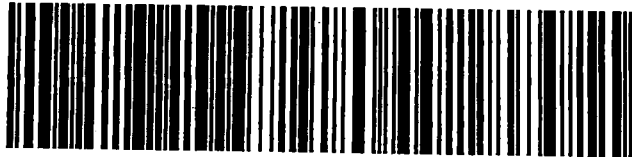
