MOTION FOR AN EXTENSION OF TIME



On October 31, 2018, counsel filed the Anders Brief of Appellant and Record on Appeal in The State v. Tony Nevail Myers with the Court of Appeals. On October 9, 2018, counsel had an oral argument in The State v. Felix Kotowski before the Court of Appeals. On October 4, 2018, counsel filed the Initial Brief of Appellant and Designation of Matter in The State v. Colette Adriane Collins with the Court of Appeals. On October 1, 2018, counsel testified by telephone in the post-conviction relief case of Jonathan Brown v. The State before the circuit court. From September 24, 2018 through September 26, 2018, counsel attended the annual Public Defender Conference in Myrtle Beach. On September 21, 2018, counsel filed the Initial Brief of Appellant and Designation of Matter in The State v. Theodore Glover with the Court of Appeals. On September 17, 2018, counsel filed the Petition for Writ of Certiorari and accompanying Appendix in Jerell Jackson v. The State with this Court. On August 30, 2018, counsel filed the Petition for Writ of Certiorari and accompanying Appendix in Roderick Germaine Wynn v. The State with this Court. On August 24, 2018, counsel filed the Petition for Writ of Certiorari and accompanying Appendix in Nehemiah J. Evans v. The State with this Court. On August 20, 2018, counsel filed the Anders Brief of Appellant and Record on Appeal in The State v. Andrew Allston Kirkland with the Court of Appeals.

5. Counsel for the Attorney General's office has been informed of this request.


